



## PPRBD Elevator Inspection Fees

- 1) **Conveyance Certificate to Operate / Temporary Certificate to Operate** – Issued after an H01 Periodic Inspection or H02 Six Month Inspection. Fees are applicable per 2023 PPRBC Appendix B, Table E.

2) **H01 – Periodic Inspection**

- a) This inspection pertains to an overall inspection and assessment of the conveyance in operation. If no violations are noted, a six-month Certificate to Operate (CO) will be issued expiring the last day of the next scheduled inspection month. If violations are noted, a Temporary Certificate to Operate (TCO) will be issued. The (TCO) will have an expiration date based on the severity of the violation at which a Re-Inspection / Resolution (H03) will be performed to either verify violations have been addressed or proceed with shutdown of the conveyance.

3) **H02 – Six Month Inspection**

- a) This inspection pertains to ongoing compliance ensuring no new issues with the conveyance operation have evolved. If no violations are noted, a six-month Certificate to Operate (CO) will be issued expiring the last day of the next scheduled inspection month. If violations are noted, a Temporary Certificate to Operate (TCO) will be issued. The (TCO) will have an

expiration date based on the severity of the violation at which a Re-Inspection / Resolution (H03) will be performed to either verify violations have been addressed or proceed with shutdown of the conveyance.

#### **4) H03 – Re-Inspection / Resolution**

- a) This inspection pertains to violations that have been noted on a previous inspection. An inspector will make a site visit to verify violations have been addressed. The inspector may also resolve violations using current technology (i.e., videos, pictures, email documentation, etc.) without making a site visit. **Each H03 entry generates a \$50.00 fee.**

#### **5) H05 – Red Tag Shutdown**

- a) This is an inspection result for a conveyance that has been shut down either by request of the building owner or from ongoing code violations that have not been resolved. All new H05 entries will generate a \$200.00 fee. A conveyance may not be returned to service until all code violations are fixed and the fees associated with that conveyance are paid in full. Elevators, escalators, and lifts that are already in H05 status will not be charged this fee.

#### **6) H06 – Elevator Witness Test**

- a) This is an inspection result from a Witness Test that has been performed with a PPRBD Licensed Conveyance Contractor. H06 Witness Tests are applicable to all types of Elevators and Platform Lifts (VPL). These inspections will be billed at \$50.00 per hour. Dumbwaiters are exempt from Witness Tests.

#### **7) H07 – Escalator Witness Test**

- a) This is an inspection result from a Witness Test that has been performed with a PPRBD Licensed Conveyance Contractor. H07 Witness Tests are applicable to all types of Escalators and Moving Walks.
